News from Treasurer Mary Van Dyck.....

I want to inform all residents about 3 important things happening in Rockland.

First, it is time to do your spring house cleaning. So to help you get rid of all those unwanted items, there will be a Electronics Recycling day at the Rockland Town Hall on April 29th from 8 a.m. to noon. Please see the insert for all items that may be brought to the electronics recycling day. I always say anything that you can plug in can be brought to this event. The recycling day is open to anyone. You do not need to live in the Town of Rockland to bring items. So if you have a friend, a co-worker, or if your school or business has items that need to be recycled, bring them on April 29th. There will be 4-H youth and adults that will help unload your items.

4-H will also have a BAKE SALE and carry out BOOYAH on Electronics Recycling Day. The 4-H youth will be using the proceeds to fund their educational trips that they will be going on this summer. Come and support a very good cause and bring your broken and unwanted items to the recycling day on April 29th.

My second important thing to report is on recycling. The Town of Rockland in 2016 collected 156.51 tons of recycled material. Let's see if we can get to 158 ton in 2017. Each year the Town does apply for a grant to help keep costs down for recycling. In order to get this grant, the Town needs to collect a standard per capita for each resident. So far the Town has met this per capita.

The third very important item is that DOG LICENSES are due by April 1st. All dogs must be licensed. This is a state law and there are no exceptions. The fee for 2017 is \$5.00 for a neutered or spayed dog OR \$10.00 for a male or female dog that is not neutered or spayed. All applications must be received by APRIL 1, 2017. Any dog license received after April 1, 2017 will be charged a late fee of \$5.00. Enclose a copy of the rabies shot history for each dog. This will be kept on file with the Town. Please make checks payable to the Town of Rockland.

Remember that your pet's license is entered into a county-wide system that can be used to locate your pet should it stray from home. Please put the tag on your pet's collar.

ROCKLAND 4-H NEWS

As we write this, Spring is in the air as we have started to look through our 4-H garden seed listings for new varieties of seeds and plants for our selection of vegetables and flowers for this years Brown County's fair. We'll probably get a blizzard next week!! So to play it safe - we have been working on Community Service programs. In February we prepared a meal and served it at the NEW Community Service shelter in West Green Bay. The members and parents prepared sloppy joes, hash browns, baked beans, fruit and made sheet cakes for strawberry shortcake. In addition, through a gift of money from the Dorothy Wozniak Foundation and money from our Food Stands - we have chosen two other areas - where we can make a difference. We have been working with St. Vincent's Hospital Children's area. We have committed to 10 Fleece Tie blankets, ceramic items cleaned and fired for



the patients to paint, and stuffed animals. Upon registration at the hospital, children/patients receive a blanket and a stuffed animal. We have delivered 5 blankets and 12 stuffed teddy bears - with more to come. Our other area to support is the DePere Bird Nest. This is a "closet" of items (new-slightly used) for special families in the DePere school district. We'll be shopping and donating laundry detergent, school supplies, socks, and other basic needs for classmates and families. Students from East DePere made a slide presentation at the February monthly meeting on their needs. March 11th was the basketball tournament at Wrightstown High School - I'm sure all that participated (playing, food stand, bake sale, silent auction)- had a great experience.

COST RECOVERY ORDINANCE

Uncommon, unusual events and catastrophic incidents have costs associated with them which can create a financial burden to the fire department and/or township because they are outside of the general, fixed and/or budgeted costs. Fire departments equip themselves with the tools they are likely to use. However, on occasion, specialized equipment such as an excavator, for example, needs to be called in. In other situations, large amounts of foam, fuel and water are used which far exceeds what is considered normal. Financially speaking, the fire department/township cannot burden these expenses or own this type of equipment due to the costs involved and the few times it would be needed. To that end, the fire department either hires, borrows, rents or commandeers what is needed. Now comes the question; who pays? By state statute, the Fire Chief has limited Police Power and has the authority to call in any needful assistance. Since the Fire Chief is sworn as such by each township, he/she acts on behalf of the municipality.

These types of expenditures do not occur very often but when they do, a mechanism (ordinance) must be in place so fire departments and/or the residents of a township are not left paying the bill. Since fire departments are non-taxing entities, the collection of these costs rests with the town who then passes them onto the property owner or responsible party. As stated in the Wisconsin Fire Service Guidebook, insurance companies are reluctant to pay for expenses if an ordinance is not in place.

Most insurance policies contain a provision for this type of expense. These extraordinary expenditures only occur during an unusual event and we want you to be aware of this ahead of time. We ask that you check with your insurance provider to be sure you have such coverage and are comfortable with the limits. Keep in mind that there is never a charge from the fire department for our services and that these types of expenses rarely occur.

In closing, we would like to thank everyone for their support and remind you to mark your calendars for our annual fund raiser which will be held on Sunday, July 16 at our Fireman's Park located on STH 32-57 just north of Greenleaf from 11 AM to 7 PM.




